## RE: GARBAGE COLLECTION

The following is a list of mandatory RULES & REGULATIONS pertaining to garbage collection:

1. ALWAYS HAVE CONTAINER TO ROADSIDE **NO LATER THAN 5:00 A.M. or PUT OUT THE NIGHT BEFORE** YOUR PICK-UP DAY. DUE TO UNFORESEEN CIRCUMSTANCES PICK-UP TIMES & DAYS CAN VARY; WE DO NOT GUARANTEE A SPECIFIC PICK-UP TIME.
2. PLACE YOUR CONTAINER **4-5 FEET** FROM THE MAIN ROADSIDE AND **4-5 FEET** FROM THE MAILBOX OR VEHICLE. IF THE CONTAINER IS TOO CLOSE TO A MAILBOX OR VEHICLE, WE WILL NOT SERVICE THE CONTAINER.
3. **ONLY OFFICIAL COFFEE COUNTY CONTAINERS WILL BE DUMPED.** NO EXTRA CONTAINERS OR BAGS OF GARBAGE BESIDE THE CONTAINER WILL BE COLLECTED. DO NOT PILE DEBRIS ON THE RIGHT OF WAY.
4. **ALL GARBAGE MUST BE PROPERLY BAGGED.** ONLY HOUSEHOLD GARBAGE WILL BE COLLECTED. NO TIRES, CAR BATTERIES, FURNITURE, HAZARDOUS MATERIAL, WOOD, BRICK, CONCRETE, YARD WASTE, ETC.
5. **COFFEE COUNTY SOLID WASTE WILL OBSERVE THE FOLLOWING HOLIDAYS: New Year's Day; Memorial Day; Independence Day; Labor Day; Thanksgiving Day; & Christmas Day.** DURING A HOLIDAY WEEK, IF ONE OF THE HOLIDAYS LISTED FALLS PRIOR TO OR ON THE DAY OF YOUR SCHEDULED PICK-UP YOUR GARBAGE WILL BE PICKED UP ONE DAY LATER. IF THE HOLIDAY FALLS ON A FRI, SAT, OR SUN, THE SCHEDULE WILL NOT CHANGE.
6. WE DO NOT CHARGE A DEPOSIT BUT WE DO REQUIRE \$53.00 FOR 3 MONTHS OF SERVICE UPON ENROLLMENT. **THEREAFTER WE BILL QUARTERLY--\$53.00.** YOU CAN ALSO PAY SEMI-ANNUALLY \$103.00 OR BY THE YEAR \$206.00.

**PLEASE NOTIFY US OF CHANGES IN YOUR BILLING ADDRESS, PHONE #, ETC.**

7. **IT IS YOUR RESPONSIBILITY TO DISCONTINUE SERVICE IF YOU MOVE. IF YOU DO NOT YOU WILL STILL BE RESPONSIBLE FOR THE BILL. IF THE CAN IS LOST, YOU ARE RESPONSIBLE FOR THE COST OF A NEW ONE WHICH IS \$75.00.**

**If your account is 90 days past due, this is a FAILURE TO COMPLY with the Solid Waste Collection and Disposal Law and will necessitate legal action as provided by the law, including charging the person in violation with a criminal misdemeanor.**

**The Alabama Law (AL Code 22-27-1, et seq.) which establishes mandatory services and participation in the collection of solid waste or garbage by Coffee County, provides that every person, household, business, industry or property owner is liable for the payment of the solid waste or garbage collection services made available.**
